Rosemary Prawdzik moves that the CMC will not consider the Triple Crown application outside of our regular grant cycle.

Linda Hughey seconds.

The motion passes unanimously.

It was requested, on behalf of the CMC, that Tom Dwyer meet with Elliott Finkelstein to express the CMC's interest in working with Triple Crown on future sporting events. Committee members expressed their concurrence in supporting these types of events but felt it could not review this particular application as it fell outside the grant funding cycle which does not go into effect until July 1.

Linda Hughey moves that the CMC postpone review of the Improv Ice application. Rosemary Prawdzik seconds.

The motion fails 2-3 with Rich Harter and Linda Hughey voting for and Rosemary Prawdzik recusing to vote due to conflict of interest.

Mike Nappa moves that CMC approve the advertising buy with Improv Ice subject to approval by City Council.

Tom Dwyer Seconds.

The motion fails 2 - 3 with Mike Nappa and Jeremy Elliott voting for and Rosemary Prawdzik recusing to vote due to conflict of interest.

Mike Nappa moves that the CMC authorizes Rod Wensing to set up zoomgrant on behalf of the CMC. Rosemary Prawdzik seconds.

The motion passes unanimously with Tom Dwyer absent from this vote.
