There are 3 phases to this and there is not currently a single staff person that has the specific expertise in tourism and retail to sell Loveland. Phase 1 is to revamp the Visitor Center to sell Loveland. Phases 2 and 3 are the implementation phases and work with search engine optimization.

The Visitor Center will be opening a separate account to track the granted funds.

The Visitor Center is a collaborative partner.

Board member Hughey expresses concern over the possibility of the work done with the grant conflicting with the overall strategic plan or possibly having to be redone.

Board member Harter would like to see how the Visitor Center sees continuing the relationship with the Commission.

Board member Dwyer inquired to the possibility of a CVB fitting in with the Chamber and Engaging Loveland.

The Commission would like to receive monthly reports on the status of this grant and an initial status report of where the Visitor Center is at the end of the year.
