CALL TO ORDER

Chair Elliott called the meeting to order at 6:05 pm.

APPROVAL OF MAY MEETING MINUTES

Commissioner Taylor made a motion to approve the May 26th meeting minutes. Commissioner Carroll seconded the motion, which passed unanimously.

PUBLIC COMMENTS

Chair Elliott asked Commissioner Jacoby to inform the commission of the Human Trafficking Awareness Event she helped host in April. 250 people attended the event in which a victim spoke about her ordeal. Restore Innocence is doing any follow up on questions or services available.

CITY COUNCIL LIAISON UPDATE

Councilor Rice confirmed that the council had filled the \$3.5 million shortfall. She stated that the City would be selling some of the automobiles. They would also share infrequently used large equipment with other communities. Employee life insurance and end of the year sick leave pay outs will be reduced. The City Council also cut out the meal prior to their Tuesday night meetings.

The A.C.E. project is moving forward and the City closed on the Agilent property today. The developer is securing tenants and council hopes to turn the title over to the developer soon.

GRANT SURVEY RESULTS

Chair Elliott spoke of the allocation presentation to council and stated, she thought it went very well. Staff handed out copies of the Grant Survey that was filled out by the agencies that applied for both the Human Services Grant and the Community Development Block Grant (CDBG). Commissioners commented that most responses were positive and they were encouraged that the grant process was easy for agencies to manage.
