

**POLICE CITIZEN ADVISORY BOARD
SEPTEMBER 12, 2011
TRAINING ROOM**

The meeting was called to order by Chairperson Pat Kistler at 5:43pm. Minutes were approved and seconded by Dennis Soucek and John Tindall respectively.

CHIEF'S UPDATE

- ✓ Chief Hecker reviewed with board members the changes that were made to the 2011 City of Loveland Comprehensive Master Plan after the special meeting that was held on 8-8-11. After reviewing the documents with the corrected changes, a motion was made by Board Member Dennis Soucek to accept the changes with Board Member John Tindall seconded, changes were approved by all members present.
- ✓ Chief Hecker reported to the Board that during this week Lt. Brown and the Loveland Police Department would be hosting Crisis Intervention Training with four Loveland police officers attending for certification.
- ✓ City Council has approved the IGA for the Northern Regional Lab Group. Fort Collins City Council was to vote the week of September 19th and Larimer County still has some questions regarding the operations and maintenance costs. Larimer County is also looking into the specifications of the design of the lab. Weld County wants to get the money allocated in the 2012 budget for the \$2 million. **Board member Swain Skeen asked if there was something the board could do to work with Larimer County in helping them show support for the lab.** Chief stated that at the present we would wait and see and that he would have more information at the next PCAB meeting. **Board member Soucek asked if there was a person who would oversee the lab.** Chief Hecker stated that at present there is a lab manager and he will continue in that capacity. **Councilor Klassen asked what the purpose of the lab was.** Chief Hecker stated that it was due to efficiencies in solving crime.
- ✓ Chief Hecker stated that Thunder in the Rockies went well over the Labor Day weekend with a minimal amount of arrests. Chief Hecker proposed to the Board for 2012 to do a walk through to see what actually goes on during the event. **The Board agreed and thought it was a great idea.**

COUNCILOR KLASSEN'S UPDATE

- ✓ Councilor Klassen briefly updated the issue regarding the power lines that are scheduled to be put up between Loveland and Fort Collins involving PRPA.
- ✓ Councilor Klassen reported that a *RFP - Request for Proposal* has been sent out for developers who are interested in the ACE project since United Properties have withdrawn from their original offer.
- ✓ Councilor Klassen stated that the councilors will be reviewing the city's budget in the next couple of weeks.

ADDITIONAL BOARD COMMENTS

The Board complimented the article that was submitted to the *Loveland Reporter Herald* on the Citizen Satisfaction Survey.

There being no further business it was moved and seconded by John Tindall and Erin Frisch to adjourn the meeting. All approved. The meeting adjourned at 6:40 pm.
