#### CALL TO ORDER

Vice-Chair Weeden-Osborn called the meeting to order at 5:15 pm.

#### **APPROVAL OF OCTOBER MEETING MINUTES**

Commissioner Thompson made a motion to approve the October 13th meeting minutes. Commissioner Salza seconded the motion, which passed unanimously.

#### **PUBLIC COMMENTS**

Carol Rush with the League of Women Voters spoke about the league's Affordable Housing team's tour of the Crossroad's Safehouse in Fort Collins which provides legal services and advocates 24 hours a day. They also toured Catholic Charities of Larimer County's new addition that will allow them to be open in the afternoons, not just at night.
