Chief Merlin Green also gave an update to FRAC on the new code adoption (IFC 2009 edition). Merlin shared on the specific changes in this new code and the action being recommended by LFR related to the exclusion of the residential sprinkler requirement from this particular code prior to adoption. There was quite a bit of dialogue concerning the code adoption and residential sprinklers as a whole.

**Public Comment/Presentation:** No public comment; however, Chief Mirowski presented the Chief's Merit Award to Citizen Nanci Garnand for her life-saving efforts by performing the Heimlich Maneuver on Rebecca Davis who was choking with a completely blocked airway. The Davis family, including Rebecca, was on hand to see Nancy receive the award.
